WHAT IS THE PRODUCT?

Type:

Société d'Investissement à Capital Variable [SICAV]

Term:

This product is not subject to any fixed term.

Objectives:

The sub-fund aims to maximise total return over the medium-to-long term by adopting distinctive value-biased active investment style by looking to investment for opportunities in undervalued, small-and-micro-cap companies with sustainable growth potential.

- The sub-fund invests at least 75% of its net assets in Japanese stocks listed on the Japanese Stock Market.
- Individual securities level: No set limit but the weight will be up to circa 5%. There is no minimum weighting and shorting is not allowed.
- Sector level: No set limit.

- The sub-fund can have its assets in money market instruments, however, the sub-fund is typically managed on a fully invested basis with circa 3% of the net asset of the sub-fund invested held in cash.

- Currency positions may be established to hedge foreign currency exposure in relation to the relevant share classes to minimise any fluctuations between the base currency and the currency of the appropriate sub-fund. The sub-fund is actively managed. It uses the Russell Nomura Small Cap Index as a reference benchmark for performance comparison. The investments of the sub-fund may deviate significantly from the components of and their respective weightings in the benchmark. Income shall remain in the sub-fund and shall increase the value of the shares. You may redeem your investment upon demand. This fund deals weekly on Tuesdays.

Intended Retail Investor:

Recommendation: The sub-fund is suitable for investors who see the sub-fund as a suitable means to participate in the capital market performance. The sub-fund is therefore suitable for investors who can afford to invest their capital over the long term i.e. a multiple year time horizon.

The risk indicator assumes you keep the product for a minimum of 5 Years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.
