WHAT IS THE PRODUCT?

Type:

Société d'Investissement à Capital Variable [SICAV]

Term:

This product is not subject to any fixed term.

Objectives:

The sub-fund aims to maximise total return over the medium-to-long term by focusing on companies with sustainable dividend payments. The sub-fund is managed on a total return basis and not relative to any benchmarks, hence not looking to be managed on a relative return basis.

- The sub-fund invests at least 75% of its net assets in Japanese stocks listed on stock exchanges in Japan. The remaining part of the portfolio will be invested in cash or cash related instruments.

- Individual securities level: The maximum weight of a single issue is 10%. There is no minimum weighting and shorting is not allowed.

- Sector level: No set limit.

- The sub-fund can have its assets in money market instruments on an ancillary basis. - Currency positions may be established to hedge foreign currency exposure in relation to the relevant share classes to minimise any fluctuations between the base currency and the currency of the appropriate sub-fund. The sub-fund is actively managed. It uses the TOPIX Total Return Index as a reference benchmark for performance comparison. The investments of the sub-fund may deviate significantly from the components of and their respective weightings in the benchmark. Income shall remain in the sub-fund and shall increase the value of the shares. You may redeem your investment upon demand. This fund deals weekly on Tuesdays.

Intended Retail Investor:

Recommendation: The sub-fund is suitable for investors who see the sub-fund as a suitable means to participate in the capital market performance. The sub-fund is therefore suitable for investors who can afford to invest their capital over the long term i.e. a multiple year time horizon.

The fund is a sub-fund of the Company which is an umbrella fund with segregated liability between sub-funds. This means that the assets and liabilities of each sub-fund are segregated by law.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator



The risk indicator assumes you keep the product for a minimum of 5 Years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the fund to pay you.
