WHAT IS THE PRODUCT?

Type:

Société d'Investissement à Capital Variable [SICAV]

Term:

This product is not subject to any fixed term.

Objectives:

The sub-fund aims for long-term growth of its assets through investment in real estate securities such as real estate investment trusts (REITs) in Asia Pacific countries and regions including Japan. Investments will focus on valuations such as dividend yield in addition to profit growth.

- The sub-fund may invest up to 100% of its net assets in equities issued by companies related to the real estate industry and/or eligible closed-ended REITs or similar eligible vehicles.

- The maximum weight of a single issue is 10%. The sub-fund can have its assets in money market instruments on an ancillary basis.

- The sub-fund may invest up to 10% of its net assets in units or shares of UCITS and/or other eligible UCIs.

- Sector level: Real estate investment trusts (REITs) in Asia Pacific countries and regions including Japan.

- Currency positions may be established to hedge foreign currency exposure in relation to the relevant share classes to minimise any fluctuations between the base currency and the currency of the appropriate sub-fund. The sub-fund is actively managed. It uses S&P Asia Pacific REIT USD Total Return Index as a reference benchmark for performance comparison. The investments of the sub-fund may deviate significantly from the components of and their respective weightings in the benchmark. Income will be monthly distributed. You may redeem your investment upon demand. This fund deals weekly on Tuesdays.

Intended Retail Investor:

Recommendation: The sub-fund is suitable for investors who see the sub-fund as a suitable means to participate in the capital market performance. The sub-fund is therefore suitable for investors who can afford to invest their capital over the long term i.e. a multiple year time horizon.

The fund is a sub-fund of the Company which is an umbrella fund with segregated liability between sub-funds. This means that the assets and liabilities of each sub-fund are segregated by law.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator



The risk indicator assumes you keep the product for a minimum of 5 Years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You [cannot / may not be able to] cash in early. You [will/may] have to pay significant extra costs to cash in early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the fund to pay you.
